**IMMIGRATION REGULATIONS**

**SECURITY BOND**  
**(Regulation 21)**

By this Bond, I \_\_\_\_\_

Whereas application under the Immigration Regulations, has been made for the grant of Student's Pass  
for myself, my particulars being as they appear in the schedule hereto:

And whereas the Student's Pass has been granted to me on the following conditions:-

- (1) that I shall comply with the provisions of the Immigration Act and any regulations made thereunder or any statutory modification or re-enactment thereof for the time being in force in Singapore;
- (2) that I shall not enter or to be retained as a student in any other school or course(s) other than that indicated in the Student's Pass;
- (3) that I shall not engage in any form of employment, or in any business, profession or occupation, whether paid or unpaid, without a valid work pass issued under the Employment of Foreign Manpower Act (Cap.91A), or in any activity which, in the opinion of the Controller of Immigration, is detrimental to the security and well-being of Singapore;
- (4) that I shall not be adopted by any Singapore Citizen(s) or Permanent Resident(s) in Singapore;
- (5) that I shall not indulge in any activity which is inconsistent with the purpose for which the Student's Pass has been issued;
- (6) that I shall not smoke, administer to myself or otherwise consume or be in any way engaged in the trafficking of any controlled drug as defined in the Misuse of Drugs Act, or any written law for the time being in force relating to the control of dangerous or otherwise harmful drugs;
- (7) that I shall not be involved in any criminal offence in Singapore;
- (8) that I shall not remain in Singapore after the expiry of the Student's Pass;
- (9) that I shall not marry a Singapore Citizen / Singapore Permanent Resident while in Singapore;
- (10) that upon my studies or course(s) as indicated in the Student's Pass being terminated for whatever reason, I shall surrender the Student's Pass for cancellation within seven days of the date of cessation or termination of my studies or course(s);

- (11) that I shall surrender the Student's Pass for cancellation within seven days if I fail to attend classes for a continuous period of seven days or more without any valid reason or that the percentage of attendance for the course in any of the month is 90% or below without any valid reason.
- (12) that I shall leave the Republic of Singapore upon the completion of my studies or course(s) as indicated in the Student's Pass and inform the Immigration & Checkpoints Authority of my means and date of departure; and
- (13) that I shall be responsible for my maintenance and repatriation;

For the avoidance of doubt, the obligations imposed herein will only cease to operate upon my departure from Singapore. The obligations herein shall, for the avoidance of doubt, continue to apply if I:

- (a) receive an extension under the Student's Pass; or
- (b) receive another pass or other passes after the expiry and / or cancellation of the Student's Pass to facilitate my departure from Singapore,

and this Bond will in such cases be read as if references to the Student's Pass are references to such other pass. My departure from Singapore will however not affect the operation of this Bond in respect of breaches prior to such departure.

In the event I shall be in breach of any or all of the aforesaid conditions, then this obligation shall be in full force and effect to the extent of \$ \_\_\_\_\_ to be paid by me.

As security for the due performance and compliance under this Bond, I hereby deposit the sum of dollars \_\_\_\_\_ (\$ \_\_\_\_\_ ) which sum shall be returned to me on this Bond ceasing, in accordance with its terms, to have effect.
